### ***Election of a new representative of the Senate to the Committee to be constituted for recommending a person for appointment as Vice-Chancellor***

It is hereby notified that an election will be held from 08.30 a.m. to 10.30 a.m. on 01.01.2013 at the special meeting of the Senate of the University of Kerala in the Senate Chamber, University Buildings, Thiruvananthapuram for electing a new member of the Senate by the members of the Senate, to fill up the vacant seat of a representative in the Committee to be constituted under Section 10 (1) of the Kerala University Act, 1974; which arises consequent to the withdrawal of membership of the previously elected member from the Senate and notified vide paper read above, for recommending a person for appointment as the Vice-Chancellor.

Only persons who are members of the Senate and whose names are on the electoral roll published in this regard on **17.12.2012** in the University Office, Thiruvananthapuram are eligible to take part in the election and vote thereat. Every voter is at liberty to nominate only one member to the above committee. Every such nominations shall be proposed by an elector whose name is in the electoral roll and seconded by another elector with his/ her signature. The candidate shall sign a declaration on it expressing his willingness to serve on the Committee, if elected.

Copy of the nomination form can be had from the office of the Registrar, University of Kerala, free of cost.

The nominations should reach the Registrar/ Returning Officer not later than **26.12.2012** 11.00 a.m. in an envelope superscribed "**NOMINATION FOR ELECTION TO THE COMMITTEE TO BE CONSTITUTED FOR RECOMMENDING A PERSON FOR APPOINTMENT AS VICE-CHANCELLOR**".
