The Dean, Faculty of Engineering and Technology recommended to give a chance to improve the sessional marks by repeating their Dissertation by completing the internal formalities as per the Regulations and appearing for the Jury and also recommended to conduct Supplementary Examinations for 13AR 1808 Dissertation.
