#### Specification for Lab furniture - SIDE TABLE

No. of units required: 2 Nos

1. Size: 30 (L) x 2.6 (W) x 3 (H) feet= 75 sq.ft.
2. GALVANIZED IRON (20awg) sheet with TATA or Jindal steel
3. Colour: Ivory and Blue
4. Good quality epoxy powder coating, thickness 60-70 micron all sides
5. Use S fasteners to prevent rust
6. Table top: 19±1 mm thick Black Pearl Granite Top with half round molding
7. Modular: It should include an assembly of modular top drawer, bottom cupboard (0.6 m width) space between adjacent 'top drawer-bottom cupboard unit' is 0.6m, provided with foot rest.
8. Electricals: 5/15 Amps socket Box 10 Nos.
9. Sink and Water tap: Made out of PP Sink size; 375×450 mm 1 no. with 3-way water tap. Executing plumbing and wiring.

#### Terms and Conditions
